RESERVATION REQUIREMENTS:

1. A valid credit card must be put on file at time of reservation. (See credit card authorization form)
2. A \$300 deposit must be made at the time of booking to a valid credit card and to guarantee your reservation date.

LIABILITY AGREEMENT:

This agreement is a contractual agreement with Escalade Limousine Company for the hire of professional chauffeured services and pertains specifically to the performance of all passengers in the vehicle from the time of pick up to time of drop off. In addition to the hourly rate for the car and chauffeur, any damage in excess of usual wear of the hired car will result in a minimum charge of \$300.00 for the repair of anything broken, damaged and/or cleaning of the vehicle above normal usage. Determination of the usual wear and use of the vehicle interior and its environs is at the discretion of Escalade Limousine Company LLC solely. If ride goes over 20 minutes you will be charged an addition 1 hour. Any changes that need to be made under the contract information field (p/u times, drop of times, address etc.) will require a signed addendum stating changes to contract one week prior to ride (if possible).

CANCELLATION POLICY:

Any Cancellation within 14 days in non-refundable and will result in full charge for the original reservation. Declined credit cards will incur a \$25.00 fee plus all charges due for the reservation.

LIMOUSINE RULES AND REGULATIONS:

1. No smoking inside the limousine, \$100.00 per incident. No exceptions.
2. A fee will be assessed for excessive clean up at the discretion of Escalade Limousine Company LLC.
3. All tolls and parking fees are not included in rental rate and are the clients' responsibility.
4. A \$10.00 fee will apply for broken or missing glasses.
5. All unruly persons will be dropped of at the sole discretion of the driver without refund.
6. Escalade Limousine Company LLC and its employees will not be responsible for lost, damaged or stolen property. Every reasonable effort will be made to return items left in vehicle to the person responsible for the reservation.
7. No illegal drug use of any kind.
8. No possession of any illegal weapons at any time.
9. Overtime will be billed accordingly.
10. The customer agrees that a replacement limousine may be substituted in the event of any major mechanical or physical damages which make the vehicle unsafe to drive.
11. All entertainment including CD's and DVD's are to be provided by client. Any damage to AV equipment will be assessed at the completion of the trip and will result in additional charges to repair or replace the damaged equipment.

RULES FOR UNDER AGED "MINORS" OCCUPANTS:

1. Any person(s) under the legal drinking age set by the state in which the reservation takes place are not permitted to consume alcohol at anytime during the hired service time. The reservation will be cancelled and appropriate action will be taken if any minor is caught drinking, using illegal drugs or is in possession of any weapons and/or illegal self defense items during the time of the hired service within or outside the vehicle.
2. Any vandalism of the vehicle or any unlawful acts by any person within the vehicle will result in:
 - a. The passenger(s) being returned to the original pick-up location.
 - b. The parent responsible for the reservation will be called to pick-up the minor from the location.
 - c. The proper authorities will be called to resolve the situation. In the unfortunate event this occurs, the charter is then over and all persons will be returned to the location of original pick-up or location designated in writing at time of reservation. All fees will be charged to the credit card in full! No exceptions!

3. Our Chauffeur will follow directions from only the acting and legal guardian responsible for the reservation unless otherwise directed in writing by the responsible party. Legal or acting guardian responsible for authorizing the reservation must be over 25 years of age with a valid credit card and legal state issued ID.
4. An emergency contact is required that will be available for the entire duration of the reservation.
5. Our chauffeurs cannot act as babysitters, disciplinarians or guardians. Our main priority is arriving safely to your desired destination.

EXPECTATIONS OF CHAUFFEUR:

Our chauffeurs will do everything possible to make sure you and your guests have an unforgettable experience. However, they are chauffeurs and not butlers. They will carry your bags and belongings to your door and/or car and help anyone in and out of the car if asked. They will assist you to the best of their ability if asked to take photos. We simply ask you treat our chauffeurs with the same respect you expect to be treated with.

CONTRACTUAL OBLIGATION:

I THE UNDERSIGNED, AGREE TO THE ABOVE RULES AND REGULATIONS SET FORTH BY ESCALADE LIMOUSINE COMPANY LLC. ALL DAMAGES ARE ASSESSED AT THE SOLE DISCRETION OF THE DRIVER. I UNDERSTAND AND AGREE TO PAY THE ENTIRE CONTRACT PRICE IF CONTRACT IS BREACHED IN ANY MATTER OUTLINED ABOVE. THE NUMBER OF HOURS I AGREED TO ON THE CONTRACT IS THE MINIMUM HOURS I AGREE TO PAY. ADDITIONAL TIME WILL BE BILLED AT CONTRACTED RATE IN HALF HOUR INCREMENTS AS PREVIOUSLY OUTLINED.
